Robert still owns a number of pedigree Holstein cattle in partnership with other breeders, which are bought and bred to produce livestock and embryos for sale, both in the UK and international export. Robert recently surrendered the tenancy on the main holding but retains other tenanted land which he operates on a drystock basis. Robert believes it is very important for the tenanted sector to be well represented, not only within the landlord community, but in all aspects of future Government agricultural policy.
